1. CRB

All proposed committee members will have to have a valid CRB certificate or will have no objection in getting one if elected.

2. PROXY

If you are unable to attend the meeting please ensure that you enclose your proxy with this form. Any nominations without proxy will be void. Telephone or email proxy will not be accepted.

3. Contest

If on the day there is more than one nomination for the same position there will be an election and you cannot withdraw from the position you have been nominated, you agree that you will contest at the election.

4. Membership Card

Please bring your membership card with you, Otherwise you will not be allowed to Vote.

ELECTION PROCEDURES

There will be an election of the following committee officers

Shree Lohana Mahajan CIO Trustees:

All Vacant post at the time of the AGM meeting.

Shree Lohana Mahajan CIO:

President, Vice president, Secretary. Joint/ Assistant Secretary, Treasurer, Joint treasurer and eight committee members.

Shree Ram Mandir:

President, Two vice Presidents, Secretary, Assistant secretary and six committee members

Mahila Mandal and Leicester young Lohana:

President, Secretary and eight committee members

Eligibility to stand for election:

Only Paid members of Shree Lohana Mahajan will be allowed to stand for any of the above position. You must be a **paid member** of Shree Lohana Mahajan at least 3 months prior to the AGM.

Person who has conviction for criminal offence, mental disorder or is an undischarged bankrupt cannot stand for any position

Any person being nominated must have served in the Committee for at least one term before being eligible for any office post.

Only paid members are allowed to complete the Nomination form and nominate.

All paid members over 18 years will be able to attend and vote at AGM.

No paid member shall be entitled to stand for two posts simultaneously in any election.

If someone proposes the name of a member who is absent at AGM to elect him/her as an office bearer or a member on the committee, then the proposer must obtain a written consent letter(proxy) that the proposed person, if elected, shall accept the post. The written consent letter (proxy) must be received by the election officer 3 days prior to the AGM.

No members will be allowed to take any post in election if he/she remains outside UK for a continuous period of 12 months and failed to attend 3 consecutive meetings.

Election Procedure

A ballot box will be kept in office during office hours. All nominations must be posted in the box. Cutoff date will be 7th June 2018. The auditor will be the key holder and will collect nomination papers from the office from time to time.
